The applicant will be responsible for all costs to include possible attorney fees and court costs incurred by Trinity Logistics, Inc. in the collections of amounts owed to Trinity Logistics by the applicant
4. It is understood, and agreed, by the applicant that a credit investigation will be completed in conjunction with this credit application. Trinity Logistics, Inc. reserves the right, at its sole discretion, to report payment experiences to credit reporting agencies.
5. The applicant attests and affirm that the information provided on this application is true and accurate, and that he/she is authorized to request credit on behalf of subject company
6. All payments are to be made in United States currency (USD)
7. Trinity Logistics, Inc. reserves the right, at its sole discretion, to assess a late fee to the customer on any and all delinquent invoices. A delinquent invoice is defined as any invoice that exceeds forty-five (45) days from the invoice date. Said late fee will be 1.5% per month or 18% per annum on outstanding delinquent balances. The late fee percentage assessment is compounded daily.
8. The laws of the State of Delaware will be applicable at all times. Venue for legal disputes will always be in a Court within the State of Delaware



Personal Guaranty

Until termination, this guaranty is unlimited as to amount or duration and shall remain in full force and effect notwithstanding any extension, compromise, adjustment, forbearance, waiver, release or discharge of any party obligor or guarantor, or release in whole or in part of any security granted for said indebtedness or compromise or adjustment thereto, and the undersigned waives all notices thereto. This guaranty is a continuing guaranty and shall remain in full effect irrespective of any interruptions in the business relations.

In the event payments due under this guaranty are not punctually paid upon demand, then the undersigned shall pay all reasonable costs and attorney's fees necessary for collection, and enforcement of this guaranty. This guaranty shall be constructed and enforced under the laws of the State of Delaware, and Trinity Logistics shall not be required to exhaust its remedies as against the Customer prior to enforcing its rights under this guaranty against the undersigned.
